*Dear Colleague,*

I would like to inform that Department of Higher Education, Ministry of Education, Government of India has been implementing a Central Sector Scheme namely Malaviya Mission Teacher Training Program (MMTTP). Guidelines of MMTTP is accessible at [https://mmc.ugc.ac.in/S/MMTTP\\_Guidelines.pdf](https://mmc.ugc.ac.in/S/MMTTP_Guidelines.pdf).

2. Through the various components like NEP Orientation & Sensitization Program, Faculty Induction Program, Short-Term Program and Refresher Course, Leadership Programs, Design & Entrepreneurship, Specific Learning Disabilities (SLDs), Promotion of Positive Mental Health, Resilience and Well-being etc. the scheme aims to sensitize the faculty about provisions of NEP 2020 and build competencies in faculty for better teaching, learning, research, and academic leadership by aligning them with Indian values and updating their knowledge and skills according to the needs of society and NEP 2020.

3. Targeted action for capacity building of the faculty of Higher Education is one of the action plans of Department of Higher Education for improved quality of Higher in line with the recommendations of NEP 2020 which provides for motivated, energised and capable faculty.

4. I would also like to inform that two programs viz. Nurturing Future Leadership Program (NFLP) and Academic Leadership Program (ALP) of 5 days duration each, are aimed at developing leadership quality in HEIs. NFLP is run by top Institutions of National Importance like IITs and IIMs targeted with the capacity building of regular faculty with 3 years of service in HEIs. ALP run by IIT Jammu targets Director/VCs/ Head of Institutions to provide them trainings in specialized area on selected issues of critical relevance.

5. We expect 50% participants (i.e. 15-20 faculty) from State Funded Public University for NFLP. Similarly, institutional heads from State Funded Public University are also allowed to participate in ALP. Application for registration / nomination of participants can be made at <https://mmc.ugc.ac.in>.

6. I would be grateful if you could kindly direct your Higher Education Institutions / State Funded Public University to leverage these capacity building programs for updating their knowledge and skills. Also, you may nominate VCs/Heads of Institutions of Universities/HEIs for the Academic Leadership Program. All relevant details are available at <https://mmc.ugc.ac.in>.
